**DYNOMITE** needs water to be activated. If sewer line is dry, cold water should be poured down the manhole after product is added. After blockage is open, flush line thoroughly with cold water.

FOR INDUSTRY: DYNOMITE is recommended for unclogging mainline drains (particularly in packing houses, processing plants, large apartment complexes, and manufacturers) where accumulation of large amounts of organic matter tend to clog drainage systems. Remove stain

Remove strainer from floor drain and add 10 lbs. of **DYNOMITE** to every 50 feet of sewer line to be treated. After blockage is open, flush line thoroughly with cold water.
