- \* **Light soil**......1 to 100 (1.5 oz./gal.) \* **Medium soi**l.......1 to 43 (3 oz./gal.)
- \* Heavy soil..........1 to 22 (6 oz./gal.)
- \* Shock treatment......Vary from 1 to 10 to 1 to 5 (13 oz. to 22 oz./gal.)
