## DIRECTIONS

#### SHAKE WELL BEFORE USE

GENERAL USE: Use Outlast as a spot, crack and crevice treatment to control cockroaches, fleas, silverfish, ticks, and water bugs. Apply this product only as a course spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet.

SPOT TREATMENT: Spray dark corners of rooms and closets. Apply to cracks and crevices in walls, baseboards, doors and window frames. For Kitchens and Bathrooms spray behind and beneath sinks, stoves, refrigerators, cabinets and around garbage cans, plumbing and other utility installations.

DO NOT SPRAY PETS WITH THIS PRODUCT.

For Ants: Spray ant trails, around doors, windows, and wherever else these pests may find entrance.

#### CRACK AND CREVICE TREATMENT:

To kill ants, black widow spiders, brown dog ticks, carpet beetles, cockroaches, crickets, fleas, scorpions, silverfish, sow bugs and spiders: Apply spray in small amounts directly into cracks and crevices. Avoid contamination of food or food handleing surfaces

STORAGE & DISPOSAL:

Storage: Store in a cool, dry place. Keep container closed.

Disposal: Replace cap and discard container in trash. Do not incinerate or puncture.
